REGISTRATION AS A CREDIT SOCIETY

We are pleased to inform that the application by TRC Multi-purpose Co-operative Society Ltd to be registered as a credit society has been approved under section 16A of the Co-operative Societies Act (Cap 62) ('the Act'). Please refer to the Notice of Registration (or 'Notice') attached to this letter.

2. The registration of TRC Multi-purpose Co-operative Society Ltd (or the 'Credit Society') to provide the financial service(s) specified in the Notice, is subject to the following condition:

The Credit Society shall not conduct any non-financial business¹ not already carried on by the Credit Society immediately before the date of registration in the Notice.

3. The condition of this registration is valid until superseded by the Registry in writing.

4. Under section 100(2) of the Act, any society which fails to comply with a term or condition of its registration, or of any approval granted by the Registrar under section 16A, shall be guilty of an offence. Under Section 100(3), every society, officer, agent, employee or member of a society or other person guilty of an offence under section 100, shall be liable on conviction to a fine not exceeding \$10,000 and,

in the case of a continuing offence, to a further fine not exceeding \$500 for every day or part thereof during which the offence continues after conviction.
